Broadland District Council has a duty planner who is on duty Monday to Friday from 08.30 to 13.00 who will meet with you at Thorpe Lodge and answer your queries and give general advice. You do not require an appointment to see the planning officer though please note that if the officer is currently with someone else, you will need to wait. You can still contact the Planning Administration Team who will answer general queries. Highways Report from Councillor Shelagh Curney Norfolk County Councillor for Hellesdon

any of you have either contacted me personally or the Parish Office to enquire what all the coloured road markings mean that we have seen painted on many of our parishes roads.

Recently Norfolk County Council has been successful in bidding for additional funding from the Department of Transport to improve drainage infrastructure around the city fringe area. As part of the "Challenge Fund" bid, several drainage improvements will be carried out in Hellesdon, Sprowston, Old Catton and Thorpe St. Andrew over the next two years. This will involve connecting roads which are currently served by boreholes and soakaways onto the existing positive drainage system.

The new system needs to be designed and the markings that residents have seen painted on the roads around Hellesdon are part of the initial survey work which is required for this. The coloured lines are identified by Operatives using ground sonar equipment, which located the buried services such as cables and pipes. The position of these cables is accurately mapped into the design plans so that there is no conflict with existing services.

More information will become available as plans and designs proceed, and I will let you all know what the timetable is for the planned works in due course.



Did You Know?

he site designated for house building on Eversley Road has connections with two of the stalwarts of Norwich Industry now unfortunately vanished from the local scene. The first being Hindes and Hardy, who had a silk mill on Oak Street. The company was founded in the early 19th century by Ephraim Hinde and was renowned for the manufacture of black mourning crepe, popular in the Victorian era, and later for the production of Silk.

In 1928 the factory was built on Eversley road, at a time of the company's expansion, to produce artificial silk. This factory employed mainly young female unemployed boot and shoe workers. The company's intention to impose double shift working at the Eversley road site resulted in industrial strife, with 70 women striking and an angry exchange of letters in the local press between the owners and the employees' trade union.

During the Second World War the factory was involved in producing fabrics for the war effort including silk and nylon for parachutes and barrage balloons. When the main factory in Oak Street was bombed in 1942 and put out of action for some months, extra shifts were worked at Eversley road to compensate. Following the cease of hostilities the main products of the company became nylon and rayon textiles. In 1961 the company consolidated its production in Norwich at the St Mary's Mill resulting in the closure of the Eversley Road factory.

At this point the second big name in Norwich's industrial history became involved in operations on the site, this being Boulton and Paul Ltd, who could trace their origins in Norwich back to 1797. The company was a major local employer in the city involved in the manufacture of structural steelwork, joinery, aircraft and wire netting during their long history. They were also involved in the building of airships until the ill-fated R101 crashed in Belgium effectively ending the British involvement with airships.

Boulton and Paul began the manufacture of aluminium windows in the old silkworks buildings on Eversley Road, employing 250 people at the time the facility was closed in 1976, thus making way for the final occupant of the site, Eastern Glazed Ceramics, who used the buildings as a warehouse and sales outlet for ceramic tiles.

FOR HELLESDON PARISH COUNCIL TRAFFIC IN HERCULES ROAD

he "Access Only" signs at the Boundary Road entrance to City View Road and at the Reepham Road ends of Mountfield Avenue, Hastings Avenue and Harlington Avenue are consistently ignored as motorists seek to avoid the Boundary Junction and this fact was brought to the July meeting of the Parish Council by a resident of Hercules Road who reported that he had counted up to 300 cars recently using this rat run morning and evening. The resident was not complaining of traffic speeding but rather of the traffic volumes.

This issue has been one of which the council has been aware for many years. It had once been proposed to close the road totally to through traffic but as residents were unable to agree which was the most suitable point for this closure to take place, it did not happen.

Fortunately the Community Speed Watch Team had the use of the portable SAM equipment scheduled for mid-July 2015 (something which happens for one week every three months or so). Using it on this occasion mainly as a counting mechanism, the following figures were obtained:

he issue raised by the resident in July coupled with these figures were discussed at the September meeting of the Property, Policy and Resources committee. Pinch points and speed bumps (though the latter are now falling out of favour) can bring a measure of relief when the complaint is one of excessive speeding but in this case it was the sheer volume that had brought the resident to the council meeting, and indeed neither of the two systems mentioned above would act as a deterrent. It should also be borne in mind that any restrictions made to this road complex must accommodate the bus service.

One specific deterrent discussed was the use of a bus gate at morning and evening peaks on the Boundary Road / City View Road junction but this would act as a bar to residents and rat-runners alike. In addition the actual volumes concerned, distressing though they may be to local residents, would not justify the expense.

As a matter of interest it should be noted that Hellesdon Low Road regularly "hosts" 900 vehicles per hour at peak times and 6-700 cars per hour are counted on Reepham Road as a matter of routine throughout the day.



OPENING & CLOSING OF RECREATION GROUND, MOUNTFIELD PARK & MEADOW WAY

s we are now leaving November behind residents are reminded that the Recreation Ground and Mountfield Park close at 4pm, with Meadow Way closing from 3.45pm. This closing is in line with the Winter schedule which applies from 1 November until the end of February. While most residents are appreciative of this, there have been occasions where Parish Council staff have been subject to abuse while undertaking unlocking and locking duties.

Whilst during the winter schedule Mountfield Park and Meadow Way is opened and closed by the Grounds staff Monday to Friday, at weekends these duties are undertaken by Caretaking staff. The opening times of the areas adhere to staff employment times and have to be considered within other required duties.

The Recreation Ground - to remind and clarify:

The gates at the Recreation Ground are opened by the Caretakers who are employed Monday to Saturday from 7.30am and Sundays from 8am. Upon entering the site the duty, providing there are no apparent unusual circumstances, is to open the vehicular access on Woodview Road. The remaining site gates are opened after the requirement to enter Hellesdon Community Centre to ensure there are no immediate issues to be dealt with.

On Sundays, in order to accommodate requirements, the opening of the Community Centre takes precedence of opening Wood View Road and the remaining site gates. Any unusual circumstances could result in action being taken that would delay or prevent unlocking of the site and this would be the case until any such circumstance is resolved.

With the number of external gates needing to be opened, it takes 20 – 30 minutes to complete unlocking therefore providing there are no unusual circumstances, the parks should be fully opened by approximately 8am and 8.30am respectively. Thank you for your co-operation.

HELLESDON PARISH COUNCIL MANAGEMENT OF OUTDOOR SURFACES IN SEVERE WEATHER CONDITIONS

Inder the terms of the Occupiers' Liability Acts 1957 and 1984 the Parish Council is responsible for taking all reasonably practicable measures to ensure the safety of all visitors to its premises and land. This includes the need for suitable precautions during severe weather conditions.

The areas covered by this policy are hard surface car parks and hard surface footways to the main entrances of buildings, and the policy has been developed following a review of the existing risk assessment.

In order to comply with the legal requirement in a practical manner, the Parish Council's policy with regard to the management of surfaces which may become hazardous due to snow and ice is as follows:

- We will ensure that areas are well-lit during times of poor visibility when the sites are open, so that obstructions and potential hazards can be seen.
- We will inspect hard surface car parks and access ways to buildings daily during severe weather conditions. We will endeavour to clear snow and ice and spread salt/grit on the cleared area to provide a designated pathway to buildings. We may take other action deemed appropriate and this may be displaying suitable notices closing car parks or other measures that may be considered practicable.
- We will not grit/salt the remainder of the parking areas or non-essential access routes.
- We will keep a log of inspections carried out and any action taken.


PROVISION OF GRIT BINS

he Parish Council as is custom and practice during winter months, receives many requests for grit bins. Grit bins are purchased by the Parish Council and are then 'gifted' to County Highways who accept the responsibility for filling and refilling. Maintenance of the bin remains with the parish; however, approval from Norfolk County Council Highways has to be gained before the siting of any grit bin on the highway. There have been occasions when approval to fund a grit bin has been obtained, only to find the agreement from highways cannot be secured. The Parish Council will not therefore fund or purchase any grit bin until highways approval is secured. Highways have criteria when considering the siting of grit bins as follows:

Would it mainly be for road or footway use?
 Use on a footway is only agreed in exceptional circumstances:

e.g. outside a shopping centre or entrance to school on a sloping gradient or on an incline

- Proximity of gradients
- Proximity to bends in road
- Proximity to footbridges
- Proximity to existing bins
- Number of premises served
- Community facilities within 200m of site
 - Winter priority routes within vicinity of site.



- Any request for a grit bin is first presented to Highways to ascertain if approval would be granted.
- A negative response would be relayed to the requester and subsequently would be made known to the Parish Council. The Parish Council would have the opportunity to challenge the Highways decision.
- A positive response would be relayed to the requester, with the request presented to the Parish Council for consideration of purchase.





The Annual Revenue Budget Hellesdon Parish Council





Il councils need to produce an annual revenue budget which sets out the financial requirements for the forthcoming year. This becomes the basis upon which spending policy is approved and how the amount of cash required in order to finance the spending plan is calculated.

The total expenditure shown above includes final payments for the build of the new office for which a loan was taken out in 2012. It also includes the final payments for the refurbishment of the skate park and the outside toilets, now recovered by S106 agreements. The figures also include capital expenditure to develop the land known as HEL2.

The above charts show where the money has come from and how it is spent for the financial year ending March 2015.

As is evident from the diagrams, employment of staff impacts extremely highly on council expenditure, with the high proportion needed for salaries and associated costs for our caretakers. The caretakers are employed by the Parish Council to predominately serve in the community centre which is managed by a group of volunteers known as Hellesdon Community Centre Board of Trustees and it registered as a charity. However, this will cease in January 2016 due to the decision of the Parish Council to bring the management of Hellesdon Community Centre in house.

The Accounts for the financial year 2014-15 have now been approved by the appointed Auditors and a copy of the documentation can be viewed on local notice boards or in the Parish Council office.
